We have been appointed as the Scrutinizer by the Board of Directors of Goyal Salt Limited (Company) pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process in respect of the below mentioned resolutions proposed at the Fifteenth Annual General Meeting (AGM) of Goyal Salt Limited on Friday, September 26<sup>th</sup>, 2025 at 11.00 A.M. (IST) through VC/OAVM.

#### A. Notice and Resolution proposed:

1. The Board of Directors of the Company has approved in their board meeting held on 26.08.2025, the Notice for Annual General Meeting, to be sent to shareholders.
2. The Board fixed 19.09.2025 as the "cut-off" date and accordingly the shareholders holding shares of the company on 19.09.2025 were entitled to vote on the resolutions as contained in the Notice.
3. The dispatch of said Notice through email and post / courier was completed by the company on 30.08.2025

5. 6. The Company had availed the e-voting facility offered by RTA for conducting remote e-voting by the Shareholders of the Company.

#### B. E-Voting Process :
