	<p><b>At present</b> our Salt Refineries and Washery at Nawa, Rajasthan has production capacity of 900 MT per day and Salt Refineries at Gandhidham, Gujarat has production capacity of 1500 MT per day which is not sufficient to meet the retail and export market demands. Hence, we intend to increase the production capacity by setting up another refinery of 700 MT in the State of Gujarat near Bharuch.</p> <p>With this expansion, our future production capacity is likely to be increased to <b>3100 MT</b> per day. With this enhanced capacity we will be one of the largest players in Salt industry in India and with this enhanced capacity we will be able to cater the retail demand and ever-growing export market demand.</p> <p>Further with refineries in both the locations where raw salts is produced in India namely Rajasthan and Gujrat, we will also be able to tap the Southern and Central India.</p> <p>The company aims to sell the major production of Bharuch, Gujrat refinery in small packing of 1kg, ½ Kg, 200 gms, 50 gms and 10 gms in the form of table salts etc.</p>
